Below for your input are what we believe are the top questions we could be asked on Thursday. I don't have an answer to the interest rate question at the bottom so we need to work on that as Jeff feels he may get asked.

We're also working on a plain language version of how this works - but it's a challenge. Any suggestions would be welcome.

Ministry are working on materials and will share their QAs and other materials once approved. I didn't know Jeff's committee commitments on Thurs and these times are what the Ministry has chosen so we may not have much flexibility to change, but no harm in asking if this is going to create issues at our end.

CURRENT PLAN FOR THURS:

- 1:30: Jeff would meet Minister and his staff at Queen's Park (location TBD)

- 2:00-2:30 News conference at QP News studio. Minister and Jeff will be at a table. IESO is not included. Minister will make opening remarks - Jeff will only be there to answer questions and will not make a statement. The Minister is the traffic cop and will decide which questions to refer to Jeff.
- 2:30 - the conference ends and Minister will leave. No expectation that we'd stay to answer questions outside the formal news conference.
