Hi everyone,

The production schedule has worked out so that we will be able to account for the release of the LTEP. My initial reading found that there are certainly references that can be made, but the LTEP doesn't challenge our core recommendations. If anything, those recommendations - for instance, the LDC share sales - will do more to meet the LTEP's goals compared to the measures announced in the document. It will be helpful to acknowledge the important details in our Energy Policy.

If anyone has any final thoughts, please send them to me no later than the end of Monday (I am on vacation until then). I will do my best to incorporate those into the final draft which will need to begin final editing and production next week to hit our Nov. 27 release date. Please let me know if you have any questions about this process.

Dear Energy Committee Members,

Please find attached a revised version of the Board's energy policy, based on our discussion at our last committee meeting and further submissions that came via email. As the discussion was mostly focused on the recommendations section, that is where the vast majority of the changes are. Notably, the Governance section now has more detail, the Procurement section has put less emphasis on Market Renewal (while still acknowledging it and providing a brief summary) and the Carbon Pricing section explicitly rejects specific targets for energy sources and technologies.

As before, this policy remains in a draft state. Once we finalize the content, we will do further formatting and editing as well as move towards a brief summary paper to accompany this comprehensive report and work to ensuring it is visually appealing.

If you have any further suggestions or comments, please send them to me no later than Monday, October 16.

Thanks for all your work on this. We're closing in on an energy policy that will make an impact.
