We are in full implementation mode for RRRP and the First Nation delivery credit (FNDC...that's our acronym for it ☺). Would you please be able to send the data/analysis related to the FN delivery credit. We will need to work with Treasury Board to ensure our forecasting and amounts being requested are as accurate as possible and we'll have a number of report backs to TB as you can imagine. We just used the \$20M from the report to let TB know the range of what this could cost, but for reporting purposes we are going to need to drill down into the details.
