You are correct, the 167K number is those that saw a credit on their bill in March. As you know, we don't track applicants after they are approved for the program so some may have moved or otherwise dropped off (e.g. we've had a few request to have their credit cancelled) or submitted another application if their circumstances have changed (e.g. new family members so qualify for a higher amount). We cannot draw a direct line from the 188 to the 167 to say that all of them are "in progress" of getting the credit applied to their account. Some will be, others won't.
