We can't verify the numbers because we don't have the benefit paid out to utilities by month and we would not know at all the amounts collected through the charge. No concerns on the OESP side.

The one question we have is on the RRRP data. Why are you showing a zero variance for the first two months of 2016? Is it because the IESO did not take over the program until March of 2016? If so, perhaps that should be explained a bit more in the file.

Are you sure that #4 is not a reporting requirement for the IESO?

I guess my overall point is, instead of having Stats Can go to two or three different places to get this information, why not coordinate with Hydro One to give Stats Can everything they need (assuming it's not confidential)? The amounts in #2 for the historical period are not something we would have on a monthly basis either. And given this issue with the First Nations, it's likely that Hydro One has to be involved to some degree or another in any event.

I've spoken to Martine again about this and I'm going to try and get some formal direction about whether we have any issues on our end with the info being released. I'll keep you posted.

Hi,

I have a bit better appreciation for this now that I have seen this email string. And I'm sorry for not following up on this; I totally forgot that this was outstanding.

Do you know who at the OEB was originally contacted by Stats Can? We seem to be going in circles on this. I've had a brief exchange with Martine and she has the same question that everyone appears to have: what is Stats Can going to do with this info? While it may not matter at the end of the day as this information, I think, is publicly available, they do expect, it appears, to want this info on a monthly basis going forward. Is this something you guys have discussed that you can provide?

As for the historical piece, I continue to be confused about item 2. The amounts paid to distributors have to be the amounts approved in regulation or in a Board order, no? So, why is this something that can't be provided by the IESO given that it appears you can provide the info for the other three items. But I could very well be missing something. By the way, has anyone asked Hydro One about the actual monthly payments to LDCs? It seems to me that if these are needed and they are not simply 1/12th of the annual amounts set by regulation or a Board order, then Hydro One may be the best source for the historical payments. As a matter of fact, I think there may be an issue with the First Nations payments. Hydro One has a contract with the First Nations that allows them to keep the amounts owing to the FNs in return for infrastructure work. I don't know much more about this but I guess it will depend on what Stats Can is using the info for. Do they want the amounts that in theory go to LDCs or the actual payments (in dollars)? I think someone needs to speak to Hydro One. This arrangement is not something the OEB approved.

What I'm going to try and coordinate on my end is the matter of whether the OEB has any concerns if the IESO was to provide this info to Stats Can. Which I think was the original question posed to the OEB about this. If it turns out that we need to do something with respect to facilitating the provision of the historical info for item #2 then we will certainly help.
