Hi Marc,

Sorry for the delay in responding.

The format looks good to me, comparing Dec31/17 and Jan1/17 with Jan 1/18, and also including DRP where applicable.

I have just a few comments or questions.

The 2018 rate for Algoma Power doesn't look right to me. With DRP, I calculated the monthly amount at 750kWh to be \$37.40 (the original without DRP is \$55.07). Perhaps I am mistaken, but maybe you could take another look. For Parry Sound – the only other LDC that would get DRP for 2018 rates at this point, it looks fine.

I would combine CNPI into one category, since all their areas have now been harmonized (Fort Erie, Port Colborne, Eastern). I calculated \$39.37 for distribution – probably a rounding error.

For Lakeland Power (excluding Parry Sound) – I believe this is effective May 1, not Jan 1. The distribution number looks correct, but could you check transmission and line loss?

The only other thing I saw was a discrepancy in Toronto Hydro residential – not much, but I got \$39.41. I didn't check the multi-unit rate. Also, I didn't look at the 2017 numbers.

Hope this helps. Let me know if there is anything else.

Hi Marc,

After looking over, I think it would be best for us if the report stayed pretty much as is. I have been looking at the report dated May 1, 2017, which I think is the last version of the report that was shared. The only columns that I think we could dispense with are the last 2 columns (**Change in Delivery Only A-B**). In the May report, this appears to be comparing May to the previous December, and seems to repeat what the first set of columns (A-B) show. The only difference is the calculation at the bottom which appears to show the **delivery impact only** on total bill. I think we can calculate this ourselves if we need it.

If this helps to simplify things for you somewhat, then I think we are comfortable with that change. Other than that, I think we would like you to continue producing the report, perhaps 2-3 times per year (e.g., after the majority of the January rate orders are released, again after the majority of the May rate orders are released, and then perhaps in September after some of the late comers are approved). There may be exceptions to this – namely, whenever rate orders for Hydro One Networks, Alectra, and Toronto Hydro are issued – because there is heightened interest in these files at the Ministry.

Does this sound reasonable to you? Please let me know, and also please accept my apology for my late response. I have been distracted from this in the last few weeks due to a number of extraneous issues that have come up. However, I consider this report that you produce to be quite an important product for us. I also think that a few others (stakeholders who want to look at rates) might find it useful, although I suspect that general members of the public probably find the bill calculator more useful.

Hope this helps, and thanks for your patience. If you would like to discuss further, please let us know.
