I believe we determined that we would take your comments, as provided on the call, into consideration when sending our next set of instructions to Leg Counsel and that you would provide written comments on the next draft of the reg, if there were still outstanding issues to be resolved.

With respect to the new regulation to provide the framework to deliver the “distribution rate protection” under the new section 79.3 of the OEBA, it would be helpful to receive written comments back from you on the draft that David shared with you on Friday.
