d:\intbl\itap5\cbpat2\plain\f0Province Releases 2017 Fall Economic Outlook and Fiscal Review

d:\intbl\itap5\cbpat2\plain\f0On November 14, the Minister of Finance, released the [2017 Fall Economic Outlook and Fiscal Review](#). The outlook and review provides an update to the fiscal and economic plan presented in the 2017 Ontario Budget.

d:\intbl\itap5\cbpat2\sb280\plain\f0The economic review echoes the government's previous commitments on energy affordability and indicates that since July 1, 2017, electricity bills have been reduced by 25 per cent on average or about \$41 per month for eligible households as a result of the Fair Hydro Plan. Approximately half a million small businesses and farms are also receiving the benefit. The statement also points to the \$100 million Affordability Fund and investments to expand natural gas in under-served areas of the province.

d:\intbl\itap5\cbpat2\sb280\plain\f0The review included an update on cap-and-trade and indicated that the first three cap-and-trade auctions generated over \$1.5 billion in proceeds which are being invested in new programs to reduce greenhouse gas emissions such as the Green Ontario Fund programs and other initiatives under the Climate Change Action Plan.

d:\intbl\itap5\cbpat2\sb280\plain\f0The statement also included significant measures for small businesses including a proposed 22 per cent cut in the Corporate Income Tax rate for small businesses — from 4.5 per cent to 3.5 per cent, effective January 1, 2018.

d:\intbl\itap5\cbpat2\sb280\plain\f0Highlights from the fiscal update:

- Government remains on track to balance the budget this fiscal year as well as in 2019-2020.
- Ontario is forecasting real GDP growth of 2.8 per cent in 2017, up from 2.3 per cent in the *2017 Budget*.
- The unemployment rate has steadily declined, reaching 5.9 per cent in October 2017.
- Net debt-to-GDP ratio is projected to fall to 37.3 per cent this fiscal year.
- Ontario is projecting that revenues will rise to \$158.2 billion in 2019–20, up from \$140.7 billion in 2016–17.
- Program expense is projected to grow from \$130.0 billion in 2016–17 to \$144.2 billion in 2019–20. This represents an average annual growth rate of 3.5 per cent. Growth in program expense over the medium term is driven by a series of investments including the electricity cost relief programs under the Fair Hydro Plan.
- Interest on debt expense is projected to grow from \$11.7 billion in 2016–17 to \$13.3 billion in 2019–20. As a result, total expense is projected to grow from \$141.7 billion in 2016–17 to \$157.4 billion in 2019–20.

d:\intbl\itap5\cbpat2\sb280\plain\f0Following the release of the economic statement, the Minister of Finance tabled Bill 177, [Stronger, Fairer Ontario Act \(Budget Measures\), 2017](#), which would implement measures contained in the 2017 Ontario budget by amending various statutes and enacting seven new statutes. Important to members, the Bill includes amendments pertaining to the accessibility of consumption data and net metering.

communications.

d\intbl\itap5\cbpat2\plain\Earlier this month, the Ontario Ministry of Environment and Climate Change (MOECC) released its outline for Ontario's Approach to Climate Change Adaptation.

d\intbl\itap5\cbpat2\sb280\plain\The proposal outlines the next steps government will take to advance climate change adaptation actions and to build resilience in a changing climate, including:

d\intbl\itap5\cbpat2\sb280\plain\Creating a new climate change adaptation organization to help build local adaptation capacity, enhance networks and take action. This organization is intended to be a one-window source for leading-edge climate projection data and adaptation information and services. The organization will work with decision-makers in communities, private businesses, and government to facilitate adaptation learning, capacity building and initiatives across Ontario.

d\intbl\itap5\cbpat2\sb280\plain\Working with climate change adaptation experts to undertake a province-wide risk assessment of the effects of climate change to better understand vulnerabilities.

d\intbl\itap5\cbpat2\plain\Ontario Progressive Conservative (PC) Leader Patrick Brown unveiled his

party's platform for the upcoming provincial election on Saturday, November 25. The document, "People's Guarantee", is designed to show voters the priorities of a PC government as well as showcase its relatively unknown leader and his approach to key issues. A large portion of the PC Platform relates to the electricity file. Key PC Platform Commitments related to electricity are as follows:

- Lower the average electricity bill by an additional 12 per cent (on top of the average 25 per cent reduction through the *Ontario Fair Hydro Plan*), through a combination of:
 - Removal of the smart meter charge from electricity bills.
 - Rebate the government's portion of the Hydro One dividend to ratepayers on their electricity bills, and commit to no further privatization of Hydro One.
 - Move conservation funding to the tax base.
 - A moratorium on new contracts, citing the existing oversupply of energy in Ontario.
 - Rescind the *Green Energy and Economy Act*, and aggressively re-negotiate or cancel current procurement projects.
 - Cut back salaries for Hydro One and OPG executives.

EDA Provides Submission to Standing Committee Reviewing *Cannabis, Smoke-Free Ontario and Road Safety Statute Law Amendment Act, 2017*

The Electricity Distributors Association (EDA) provided a submission to the Standing Committee on Justice which is reviewing Bill 174, *Cannabis, Smoke-Free Ontario and Road Safety Statute Law Amendment Act, 2017*.

The EDA's submission is focused on the implications to workplace and public safety of a plan to legalize recreational cannabis. These concerns were also raised during the association's meeting with the Office of the Attorney General in October.

The EDA noted it is pleased to see that many provisions in the legislation do address safety-related concerns. In particular, the provision bans the use of recreational cannabis from public places, workplaces or inside a motor vehicle. The EDA also supported the provision of the legislation that creates a zero-tolerance approach prohibiting commercial drivers from having the presence of either alcohol or drugs in their system, as detected by a federally approved screening device.

The EDA's submission encourages the Standing Committee to provide for language in the legislation which maintains workplace rights around zero-tolerance policies for all on the job forms of alcohol and drug impairments.

EDA Participates in IESO's Regional Forums

EDA has been making its rounds attending several of the IESO's Regional Forums.

In October the EDA President and CEO Teresa Sarkesian participated as a guest panelist at the IESO's Northwest Regional Electricity Forum.

Continuing the EDA tour, EDA Chair Vinay Sharma participated as a guest speaker at the IESO's Northeast Ontario Regional Forum on November 9, 2017 hosted in Sudbury.

Vinay's presentation highlighted how the changing electricity landscape is encouraging LDC transformation to become more customer-centric and how consumers are at the forefront of this change. The presentation pointed to the EDA's Vision Paper: The Power to Connect and how distributed energy resources are key to a reliable, clean and innovative grid.

The forum also included a keynote address by Frank Kallonen, President & CEO, Greater Sudbury Hydro addressing Greater Sudbury Hydro's experience within the evolving electricity sector.

IESO's Regional Forums gather local leaders, community members, industry experts, local groups and associations together to discuss the future direction of the electricity sector and regional-specific electricity issues.

On November 16, EDA Vice Chair Brian Wilkie in the the East Ontario Regional Forum in Ottawa, also speaking about the changing electricity Landscape.

Jim Keech, President & CEO, Utilities Kingston, presented on Utilities Kingston's experience within the evolving electricity sector. The event also included a presentation from Ottawa River Power Corporation on their energy management strategy and a panel discussion on planning for the electricity system of today and tomorrow, which included Hydro Ottawa as one of the guest panelist.

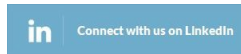
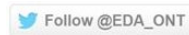
