d\plainThe province's ban on hydro companies disconnecting customers for late payments during the winter months comes to an end on May 1st. That will make for some large bills that some customers might find difficult to pay. The idea was to ensure electricity, especially electric heating, stayed on for everyone during the coldest months, but the ban on pulling the plug on delinquent customers in Sudbury is affecting hydro's bottom line. "With the disconnection ban in place, we don't have the course of action to shut hydro off. So, as a result, it is easier for customers to go without paying their bill during those months." said Victoria Benkovich, communications director Greater Sudbury Utilities.

d\plainWhile GSU thinks some customers might have taken the winter ban as an opportunity to take a break from paying their bills, the experience over at Hydro One, on the other hand, has been a little different.

"We've actually seen both our disconnections come down by 50, roughly 57%, since 2016 and our accounts receivable are also down tracking about the same amount. So, we've got a situation where we've actually got more people connected and more people actually servicing their bill." said Pugliese.

d\plainHydro One VP says by relaxing collections policies the company has encouraged more customers to get proactive with overdue bills, instead of hiding from them.

d\plainGSU also has a saying, that it's in the distribution business, not the disconnection business, and as long as customers reach out to them, they can help them work out a payment plan and keep the lights on.

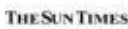

The sale of **Peterborough Distribution** Inc. (PDI) to **Hydro** One is back on, but the City of **Peterborough** is emphatic that the main points of the deal remain unchanged.

It was revealed at a special council meeting Monday that negotiations between the two parties had reignited, after it was announced on March 9 that talks had ended.

Although the reasons behind the ceasefire of negotiations has not been publicly discussed, chief administrative officer Allan Seabrooke said they won't affect the deal moving forward. "What council approved and what the offer was, that was our basis, and that has not changed," he said.

That deal included a sale of \$105 million with a five-year **rate** freeze for customers, as well as protections for jobs.

The CAO said those conditions cannot change during negotiations, and if they do the deal would have to go back to council for approval.

"Those are really the only two courses of action that could happen," he said, adding if a deal were reached outside those parameters "we would not have authority to be signing."

Seabrooke also gave some insight as to how the deal restarted.

He said that since the end of negotiations with **Hydro** One, ongoing since council approved the sale in 2016, both parties continued talking behind the scenes. Through those conversations, it was mutually agreed to continue work on the deal.

But Seabrooke emphasized that **Hydro** One won't gain an advantage in negotiations by temporarily calling off the transaction. "I don't think it changes anything," he said.

Seabrooke said it's too early to say if negotiations will stretch into 2019.

"When we have something concluded either way we will report it at that time," he said.

The decision to sell the **utility's distribution** to **Hydro** One was unpopular among some residents.

Sandra More is one of them. She's part of a citizen-activist group called Save PDI.

When she heard **Hydro** One was calling off the deal in March, she said, she was initially excited, but she's disappointed to hear it's back on. More says her group will continue to fight against the deal and to keep local **utilities public**.

The next steps, she said, will likely involve renewed conversations among the group and an appearance at the next city council meeting on Monday.

"I'm not for privatizing publicly owned **utilities**," she said.

Coun. Keith Riel agrees.

He's been a vocal opponent of the sale since it was first introduced and he says at the special committee meeting he was "blind-sided" by the news the deal was still on.

"As far as I was concerned, it was a done deal," he said of the negotiations ending.

When **Hydro** One announced it was ending talks the city should have moved on, he said, especially since the majority of the **public** is against it.

He also said he learned Mayor Daryl Bennett met with **Hydro** One CEO Mayo Schmidt to continue negotiations, something he did not know about beforehand.

Why **Hydro** One would announce the deal was dead then return to the table with is unknown, adds Riel, but he said the company likely didn't see profit to be made in **Peterborough**.

Ron Butterworth, who worked in **Peterborough's utilities** for more than 30 years, said he's tired of negotiations happening behind the scenes and says the city has been using "backroom tactics" to get what it wants.

He also questioned why the city would not reconsider selling PDI after **Hydro** One announced it would not continue to seek a deal.

"Can they do this or should it be a fresh process, transparent and open to all?" he said.

Butterworth also says the city should have started a bidding process for the sale of PDI as there were other buyers who were locked out from making offers due to the closed process.

Situations like **Hydro** One's on, then off, and now on again attempt to buy **Peterborough's electricity distribution** network.

How to "unpack" that one?

Hydro One first approached city-owned **Peterborough Utilities** Inc. (PUI) nearly four years ago with an offer for its "poles and **wires**" business.

Just six weeks ago, the behemoth **utility** company suddenly announced it was no longer interested in the \$105-million deal it had agreed to.

PUI officials were mystified. So was city council, which had narrowly approved

the sale over the objections of many very vocal protesters.

A second surprise came late last week when the **Ontario Energy Board** turned down **Hydro One's application** to buy **Orillia's distribution** network. Terms of that deal were very similar to what was proposed here.

Maybe the **OEB** ruling cleared up the local mystery. **Hydro One** had been getting resistance from the **OEB** on the **Orillia** purchase and might have anticipated rejection. Maybe, expecting a similar loss if it took the **Peterborough** purchase to a hearing, **Hydro One** managers decided to walk away rather than waste their time and money.

Except that the opposite seems to be true. City council heard Monday that **Hydro One** is back in the game. Its \$105-million offer stands and negotiations will restart.

The reasons behind **Hydro One's** flip-flop remain a mystery, at least for now.

We'll turn our "unpacking" attention to what the **Orillia** decision could mean for **Peterborough utility** customers.

One possibility is that **Hydro One** will be forced to improve its offer.

In **Orillia**, the **OEB** was concerned that **utility rates** would go up in the long run. A guaranteed one-per-cent **rate** drop in the first year followed by a virtual freeze for the next five years - offered both here and in **Orillia** - was not good enough.

The **OEB** looked at three other **distribution networks** **Hydro One** bought recently where projections apparently now show big increases 10 years out for some customers.

Hydro One couldn't, or didn't, prove that **rates** in **Orillia** wouldn't eventually go up beyond what the local **utility** would have charged. To get the **Peterborough** purchase approved it would have to.

But maybe it didn't answer the **OEB's rate** concerns in **Orillia** because it couldn't. Maybe selling to **Hydro One** wouldn't be best for **Peterborough utility** customers, regardless of what PUI managers have said all along.

It appears the **OEB** is not interested in arguments about coming capital costs and a declining **customer** base that **Hydro One** is better equipped to handle.

With that in mind, PUI managers have to prove they are right. They, not just **Hydro One**, need to answer the **OEB's** concerns about long-term **rate** hikes and show how this sale would limit them.

Without a sale PUI would potentially be out \$1 million worth of legal and consulting costs that have piled up so far, but decades of higher than necessary **rate** increases would be even more expensive.

The would-be partners in this four-year journey need to come up with the right answers. If not, their long-delayed deal will go on permanent vacation.

Our increasing **electricity rates** were not due to **Hydro** One or solely to the **Green Energy Act**, but rather to political meddling in the **energy** sector.

Aside from billions in extra financing costs, we can look forward to the "Clean **Energy** Adjustment" on our bill in addition to the "Global Adjustment." Equally, this "Market Distortion **Plan**" does nothing to promote conservation or stimulate innovation, in fact it does the opposite.

We need more fact-over-fiction debate in **energy** and other sectors if we hope to encourage sound policy and innovation, and in **energy**, to achieve our climatechange and affordability goals.

The **Ontario** election campaign hasn't officially begun, but we have a clear symbol of the divide between the two traditional leading parties.

The symbol is **Hydro**. One chief executive Mayo Schmidt, nicknamed the \$6-million man by PC leader Doug Ford.

The handle is based on Schmidt's annual salary and bonuses that total \$6.2 million. That is double his next highest-paid provincial counterpart, and 10 times that of some CEOs in smaller provinces.

As if that weren't shameful enough, the **Hydro** One board has increased any severance package.

These changes mean Schmidt would be eligible for a platinum handshake of \$10.7 million if he were terminated after a change of control of the company. The poor man would get only \$5.04 million if he were terminated under other circumstances, without a change of control.

Ford has promised to fire Schmidt and the entire board if he wins the election. That won't be easy since the Wynne Liberals sold off a majority share of the **utility**, so the province does not have control.

Energy Minister **Glenn Thibeault** said Ford's **plan** will do nothing to help keep **electricity rates** low.

Schmidt's \$6 million is a drop in the bucket of the **utility's** total annual compensation budget of more than \$400 million.

But the salary issue is more about optics than it is about saving the cash.

Ford's message is he'll be all over the financial excesses that have been a hallmark of this government.

An article in the National Post last week nailed another issue in the election. The headline read: "**Ontario** premier predicts 'vicious' election campaign, then gets vicious."

In the article, written by Kelly McParland, Wynne made it clear, as have others in her cabinet, that they're going to smear Ford as Donald Trump light, in an attempt to send him back to **Toronto** with his tail between his legs.

Wynne said her attack was to alert voters that the race was bound to be nasty. "It's crystal clear that this is going to be a vicious campaign," Wynne said.

As McParland pointed out, "to let people know things might get ugly, she got ugly."

I carry no brief for Doug Ford. In fact, he worries me.

But based on her record as an uninspired leader and incompetent manager, **Ontario** cannot afford to re-elect Kathleen Wynne.

One poll last week showed the NDP might actually finish second and the Liberals third, so low it would not retain official party status.

That NDP strength comes in part from worries about Ford and the low opinion **Ontario** voters hold for Wynne.

Andrea Horwath's actions in recent years have shown little of the promise of her early days as NDP leader, but she still might rise to the occasion.

The Trillium and Green parties have no chance of electing enough MPPs to form a government.

So, if we're stuck with Ford, we'll have to find a way to make the best of it.

The Liberals could use the next four years to lick their wounds, find a leader who actually cares about people and the entire province including rural **Ontario**, and come roaring back to save us from too much Ford damage.

It's a bleak outlook, but one to which we have no alternatives.

On Monday, the nuclear **power** plant operator announced advanced manufacturing contracts with four manufacturers totalling \$914 million.

"By signing these contracts today, we have secured Made in **Ontario** solutions for the components we will need to successfully complete our MCR projects, extending the life of our site to 2064," Bruce **Power** president and CEO Mike Rencheck said in a news release. "Today's announcements represent a \$914-million investment in **Ontario**'s highly skilled workforce, which will create untold economic opportunities for the communities in which they operate for many years to come."

Among the contracts announced Monday were \$642 million to BWXT Canada Inc. to manufacture 32 steam generators at its Cambridge facility; \$144 million to Laker **Energy** Products for end fittings, liners and flow elements at its **Oakville** location; \$62 million for Cameco Fuel Manufacturing in Cobourg for calandria tubes and annulus spacers for all six MCRs; and \$66 million for Nu-Tech Precision Metals in Arnprior for the production of zirconium alloy pressure tubes for units 6 and 3.

The major component replacement is slated to get underway in 2020 beginning with Unit 6, with units 3 to 8 all to eventually be refurbished, extending the life of the site through 2064. Bruce **Power** plans to invest \$13 billion of its own money into the project, which actually began in 2016 with asset management program investments.

By extending the life of the site, the company has said it will create and sustain 22,000 jobs annually, both directly and indirectly, across **Ontario**, while investing \$4 billion a year into the **Ontario** economy.

Bruce **Power** spokesperson John Peevers said Tuesday that Monday's big announcement obviously has a major impact on the communities where the affected companies are located, but it is also good news for the region around Bruce **Power**.

"The further we get into the process and the closer we get to embarking on that first major component replacement the more spinoff there will be locally, the more incentive there is for some of these companies who haven't located in the area to do so," said Peevers. "We are hearing and finding that some of the people who have already set up shop in Bruce-Grey-**Huron** are looking to expand again."

So far more than a dozen suppliers of Bruce **Power** have expanded in the area, more than doubling the number of Bruce **Power** suppliers with a local presence with more expected to come.

"We are told there are more coming, and I have talked to some that are talking about expanding," said Peevers. "We expect that will continue this year."

Peevers said the contracts announced on Monday were some of the biggest for the major component replacement, but more contracts will be signed in the future.

"We have definitely knocked down some of the big ones, but there are still more to come," said Peevers. "We will continue to keep the community informed about those as we go."

On Monday, **Ontario Energy** Minister **Glenn Thibeault** called the announcement good news for the people of **Ontario**.

"Bruce **Power**'s Life Extension Program makes sense for **Ontario**, and the announcements made today will create good jobs and benefit our economy for decades to come," Thibeault said in the news release. "Moving forward with the refurbishment project is part of our government's **plan** to support care and opportunity, while producing affordable, reliable and clean **energy** for the people of **Ontario**."
