Dear Jeff:

I am pleased to provide you with the Ontario Energy Board's Strategic Blueprint: Keeping Pace with an Evolving Energy Sector.

As the energy sector undergoes a period of accelerated change, the Blueprint will serve as a roadmap that will guide the OEB's work over the next five years. It will sharpen our focus on efficiency, cost-effectiveness, innovation, value for consumers, as well as our own effectiveness as a regulator. The Blueprint's fresh direction combines the OEB's current approach to consumer-centric regulation with a stronger emphasis on the new and different challenges expected ahead.

The Blueprint focuses on four interconnected strategic challenges:

1. Transformation & Consumer Voice – How can the OEB help ensure that the evolution of the sector brings a stronger focus on demonstrable value for consumers?
2. Innovation & Consumer Choice – How can the OEB incent and enable innovation that enhances consumer choice and control?
3. Consumer Confidence – How can the OEB strengthen and sustain the confidence of consumers during a period of accelerating change?
4. Regulation "Fit for Purpose" – How should the OEB equip itself to meet the challenges of sector transformation?

To support our endeavours in meeting these challenges, we will soon be bringing together a group of stakeholders that will work with the OEB to help us better understand and identify action items and priorities we can consider to better enable and leverage innovation by regulated utilities. We have asked Paul Murphy, currently Chair of MaRS Advanced Energy Centre's Advisory Board to work with us to help establish and lead the group.



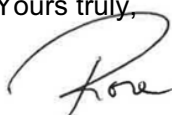
