- o The **Ontario Energy Board** has completed its review of the Energy East pipeline project on behalf of the Minister of Energy. The Board has submitted its report to the Minister, which will inform of the government's participation on the project at the National Energy Board.
- o Lobbying efforts are designed to ensure government has all of the facts and information concerning the proposed project.
- o The focus is project development and business development in the province and continued viability and fair treatment of our existing operations.
- o Other government policy and/or Programs of interest include: Cap and Trade, Climate Change Action Plan, Long-Term Energy Plan (LTEP), Government Procurements including: Large Renewable Procurement (LRP 11), Bruce Power Refurbishment Implementation Agreement (BPRIA).

- o The EDA is lobbying on the Climate Change Action Plan stemming from the

Climate Change Mitigations and Low Carbon Economy Act, 2016.

- o The EDA's advocacy focuses on working collaboratively with government to address the plan's multiple touch points for electricity utilities, specifically in areas such as electric vehicle infrastructure, energy retrofits and the 'green bank'; also the EDA continues to encourage government to ensure the new Cap and Trade system does not negatively impact efforts at electricity conservation by eroding the business cases of proposed Combined Heat and Power projects.
- o The EDA will also be lobbying on the Long Term Energy Plan as the association advocates for a larger scope to the plan to include innovation and shared service models for utilities; along with energy literacy, conservation and consolidation incentives.
