Queen's Park adjourns for the summer; EDA analysis of the political landscape

The legislature at Queen's Park adjourned for the summer on June 1. Members of Provincial Parliament (MPPs) from all three parties will now spend the final summer ahead of next year's election meeting with constituents and will be pushing their key messages to voters across the province. The EDA is providing the following analysis on the current political environment in Ontario.

Since the session ended, media speculation has focused on whether the Premier will wait until June 7, 2018 before going to the polls, but most analysts believe there are pros and cons to each option. Premier Wynne, when pressed by the media, indicated that the intent is to stick to the original date.

The political landscape has not changed in any significant way since the beginning of the year. The governing Liberals remain behind in most opinion polls, but have announced numerous policy changes and legislation that they believe will resonate with the electorate and improve their standing. The message that they will advance over the summer includes a balanced budget, support for the Fair Hydro Plan rate reduction on electricity bills, pharmacare for children under 25 and a \$15-dollar minimum wage as part of a wide-reaching package of labour reforms.

The PC Party ended the session on a high note with a by-election win in the riding of Sault Ste. Marie, a former Liberal seat that has not voted for a PC MPP since 1981. It was also disclosed that the PCs raised more money than the Liberals in the last year. The PCs, who continue to lead in opinion polls, will spend the summer highlighting their perceived failings of the government, while raising the profile of their leader Patrick Brown across the province.

NDP Leader Andrea Horwath will enter the summer season with more defined policies than her PC counterpart. The NDP put forward their own electricity platform in the last session calling for measures that, in their estimation, would have reduced bills by an average of 30 per cent. The NDP are also claiming credit for pushing the government to accept a \$15-dollar minimum wage policy. The primary focus of the NDP leader is to better define the party and her leadership to voters than has been done in the past.

In September, unless a snap election is called, LDC members can expect a louder and more combative session of the legislature as all three parties begin drawing their battle lines over both policy and personality. Although the election is one year away, it seems that the campaign has already begun.

OEB staff release report on proposed cyber security framework

LDC members should have received a [RapidSource](#) last week regarding an OEB staff report on a proposed cyber security framework, which was released for comment. The EDA will engage members through its Operations and Engineering Council to provide feedback on the following items by the July 15 deadline:

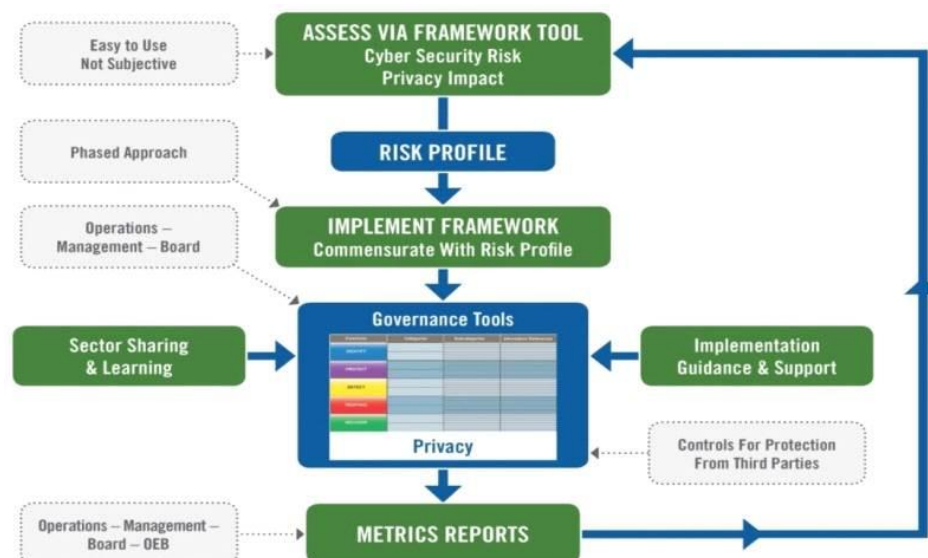
- Regulatory requirements and reporting;
- Additional implementation tools and guidance required;
- Adequate guidance with respect to integration of privacy requirements; and
- Other aspects to be incorporated.

The objectives of the OEB's proposed framework are to safeguard information, protect systems and operations and protect against risks using best practices. It is also meant to support electricity and natural gas distributors in assessing risk and controls, implementing appropriate governance and providing the OEB with assurances of achieving the appropriate level of cyber maturity.

Within three months of the adoption of the final framework, OEB staff propose that distributors

will file an interim report that assesses their cyber security and, thereafter, will report annually on their cyber security capability. In future, distributors are expected to participate in a mandatory Cyber Security Information Sharing Forum.

LDCs encouraged to complete OEB survey on incentive rate-setting mechanism

The survey is open until June 19.

LDCs should have received a letter from the Ontario Energy Board (OEB) earlier this week about its annual survey on Price Cap Incentive Rate (IR) and Annual IR applications. The letter specifically requests LDCs to identify the rate-setting approach and the elements they will include in their applications, such as:

- Z Factor claim
- Incremental Capital Module claim
- Lost Revenue Adjustment Mechanism ("LRAM") Variance account disposition
- Rate Harmonization pursuant to a prior OEB decision
- Renewable Generation and/or Smart Grid Adder request
- Multiple service areas with different rates
- Migration of customers into or out of Class A (Global Adjustment and CBR)
- Other

According to the OEB's Handbook for Utility Rate Applications, IR methodologies were developed to move towards an outcomes-based approach to rate-setting and give utilities the necessary tools to develop business plans that meet their needs. This specific survey is intended to support the processing of LDCs' IR applications, which is why the EDA encourages members to complete the survey.

Artwork for new Ontario Fair Hydro Plan bill inserts now available

LDC members should have received a RapidSource earlier this week regarding the new, mandatory bill insert for Ontario's Fair Hydro Plan (FHP). With the passing of *Ontario's Fair Hydro Act, 2017*, the Ministry of Energy is sharing the artwork with LDC members to help them raise awareness of the FHP.

Under the [proposed regulation](#), LDCs are required to issue this bill insert on a quarterly basis, beginning with the first bill on or after July 1, 2017. **As the regulation is not yet final, members are reminded that the text in the insert is subject to change** and printing and distribution processes should be planned accordingly.

REMINDER: Comments on proposed Fair Hydro Plan regulations due June 10

The EDA would like to remind members that the Ministry of Energy has issued several regulatory postings for comment to support the implementation of Ontario's Fair Hydro Plan. **Comments are due by June 10.**

The EDA has engaged its Regulatory Council on the proposed regulations and will continue to participate on the ministry's Fair Hydro Plan Working Group to address implementation and communications issues for the plan.

A summary of the postings can be found below:

[Bill presentment](#)

The Ministry of Energy is proposing amendments that would remove outdated messages from invoices, introduce new messages related to the *Ontario Fair Hydro Plan Act* (OFHPA) and inform customers about bill impacts. The proposed regulation outlines the required language for invoices and bill inserts.

[Re-financing the Global Adjustment \(GA\)](#)

The proposed regulatory amendments concern the re-financing of a portion of the GA as contemplated in the OFHPA, and provide the IESO and LDCs the necessary authority related to their OFHPA activities.

[Social programs](#)

This posting proposes new regulations under the *Ontario Energy Board Act* (OEBA) to provide the framework for the delivery of broadened distribution rate protection, First Nations Delivery Credit and a streamlined application process for the Ontario Electricity Support Program.

Fair Hydro Plan, customer engagement and merger communications addressed by Communicators Council

LDC communicators and customer service professionals from across Ontario met last week to address the province's Fair Hydro Plan, customer engagement and merger communications.

The Ministry of Energy provided an overview of its communications strategy for the Fair Hydro Plan, on which members provided feedback. The ministry noted that materials, including new bill inserts, would be distributed to LDCs through the EDA in the coming weeks.

BEworks held a workshop on customer engagement, showcasing examples of successful initiatives such as bill re-design that leveraged principles of behavioural science.

Members also received a presentation from Alectra Utilities, which offered insight into the

complexities of merger communications and branding.

Federal government to develop a zero-emissions vehicle strategy by 2018

The Government of Canada recently announced that it will work with provincial, territorial and industry partners to develop a national strategy to increase the number of zero-emission vehicles (ZEVs) on Canadian roads by 2018 – an initiative that affects the LDC sector in Ontario.

A national Advisory Group has been established to help develop options for addressing barriers to deploying ZEVs (electric, plug-in hybrid and hydrogen fuel cell vehicles), with a focus on the following issues:

- Vehicle supply
- Cost and benefits of ownership
- Infrastructure readiness
- Public awareness
- Clean growth and clean jobs

This announcement comes on the heels of federal budget announcements of \$62.5 million in 2016 and an additional \$120 million through Budget 2017 to support electric vehicle charging and refueling stations as well as technology demonstration programs.

The EDA will monitor the developments of the Advisory Group and what this strategy will mean for the adoption and integration of ZEVs in Ontario.
