Hi Rose,

We received the attached communications plan from Hydro One yesterday. I had thought that in light of our anticipated website posting in relation to FHP impacts on consumers, we were of the view that we would not review/approve any HONI Comms Plan, but I don't think that this was communicated to HONI. I did open and review the document (not sure whether you want to do that or not) and as it turns out the social media plans are fairly standard and the messages themselves are mostly benign. Anything coming close to a "sales pitch" is fact based and could be easily gleaned from a review of the application.

It also confirms HONI's commitment to assist with the advertising of the community meetings which is positive. I have copied John B. for his thoughts.

My preference is to respond without indicating that we have reviewed it and certainly not that we are approving the contents.

Rather, I would suggest saying something in the nature of "Thank you for sharing this document, we will make our call centre and public affairs group aware of it so that they can be prepared for any questions or comments they receive from the public or media."

I expect that if I do not respond, HONI will proceed with the plan in any case, but at the very least I would like to acknowledge receipt.

Please let me know if you are directionally in agreement with the approach.
