HIGHLIGHTS OF 1998

CORPORATE SERVICES

- full computerization of accounting and financial records of the Authority
- developed policies, procedures, programs and services which ensured watershed residents and municipalities received the most value for their dollars
- ensured accountability to member municipalities, ratepayers, partners and senior levels of government
- provided training and part-time employment opportunities for 60 individuals from the local community
- joined the Elgin Middlesex Oxford Purchasing Cooperative

COMMUNITY INFORMATION/EDUCATION

- developed a Marketing Communications Strategy
- provided financial and human resources to other community partners to produce various environmental publications for Elgin County
- member of Volunteer Elgin
- active participant in the newly formed Southwestern Ontario Leave A Legacy Program
- joined the provincial Conservation Services Cooperative to access printed resource materials for distribution to landowners through the CCCA Resource Centre

FORESTRY

- 23,050 trees planted throughout the watershed to improve air and water quality and enhance wildlife habitat
- supplied and planted native trees at various Conservation Areas through the Community Forest Commemorative Program
- provided certified staff to approve Managed Forest Tax Incentive Program Plans for private landowners
- completed Management Plans for Authority owned Agreement Forests
- delivered large stock hardwoods to local municipalities for road-side planting
- provided landowners with technical expertise and a wide range of tree planting services
- implemented a Tree Marking Program for municipalities and private landowners



Soil Conservation

SOIL CONSERVATION

- designed and constructed two streambank stabilization projects incorporating bio-engineering techniques and native tall grass prairie plantings
- completed fisheries rehabilitation projects in the Town of Aylmer on Catfish Creek and Bradley Creek
- provided new demonstration sites for the public to view

FLOOD FORECASTING AND WARNING

- worked with Environment Canada to install and program new water level equipment
- maintenance and operation of four water level gauges and one weather station
- channel sounding and map production to determine potential dredging sites in Port Bruce
- removed 6000 cubic yards of material from Catfish Creek in Port Bruce for flood control purposes
- pro-active Ice Monitoring Program
- operation and maintenance of the Springwater Dam
- examined more effective ways and means of dealing with ice jams in the Hamlet of Port Bruce
- updated Flood Warning and Operations Plans to incorporate changes through municipal restructuring

CONSERVATION AREAS

- upgraded the electrical services at the Springwater C.A.
- installed a new septic system at the 1885 Springwater Schoolhouse
- stabilized and rehabilitated sections of the Springwater Pond shoreline through the Community Fisheries Improvement Program
- completed trail improvements in the Springwater Forest
- provided easements to the Town of Aylmer for the installation of municipal services to improve water quality

ENVIRONMENTALLY SIGNIFICANT AREAS PROTECTION

- 1998 Calton Swamp Operational Agreement with Aylmer District Ministry of Natural Resources
- accepted a land donation along Bradley Creek
- developed stronger partnerships with national, provincial, & local agencies in coordinating significant land protection
- identified and mapped Authority properties eligible for the Conservation Land Tax Rebate Program
- acquisition and stewardship of Provincially Significant Areas
- hosted a workshop with Nature Conservancy Canada to educate the public on the significance of Carolinian Canada

ENVIRONMENTAL PLANNING

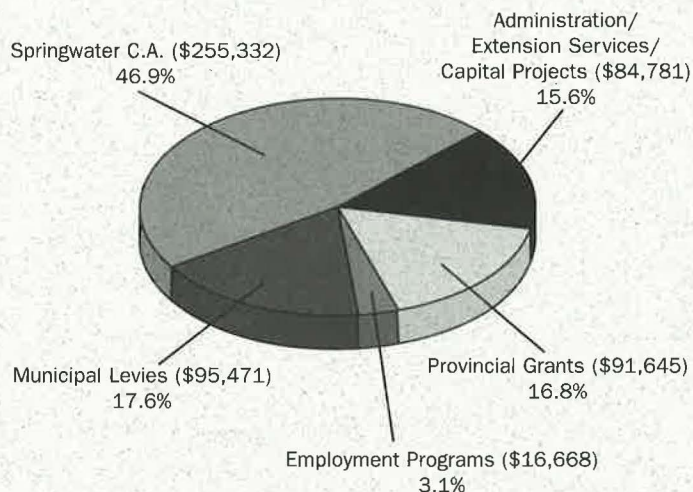
- worked to protect valley lands and flood plain areas by processing 13 permits under Section 28 Regulations of the Conservation Authorities Act
- provided environmental input to watershed municipalities by responding to 70 Planning Act applications or documents
- reviewed and provided comments on 9 Municipal Drain Reports
- reviewed 52 property inquiries (legal, real estate and general information)
- further developed the Authority's GIS capabilities
- improved water quality within Bradley Creek by working with Mid-Erie Developments and the Town of Aylmer to provide an effective natural stormwater management system for a new subdivision
- signed an Agreement with the Department of Fisheries and Oceans to protect and promote healthy fisheries within the watershed

COMMUNITY PARTNERSHIPS

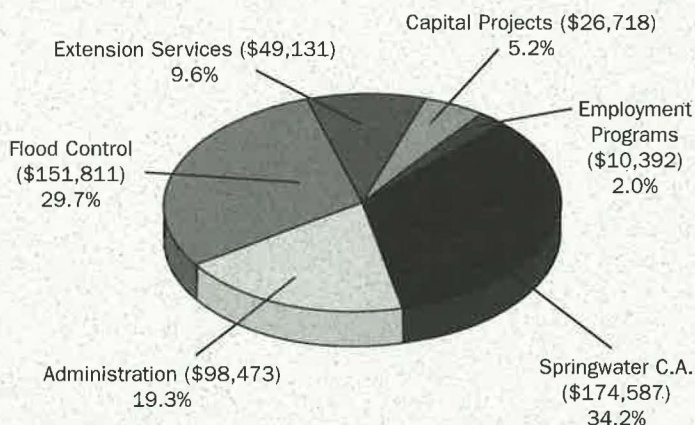

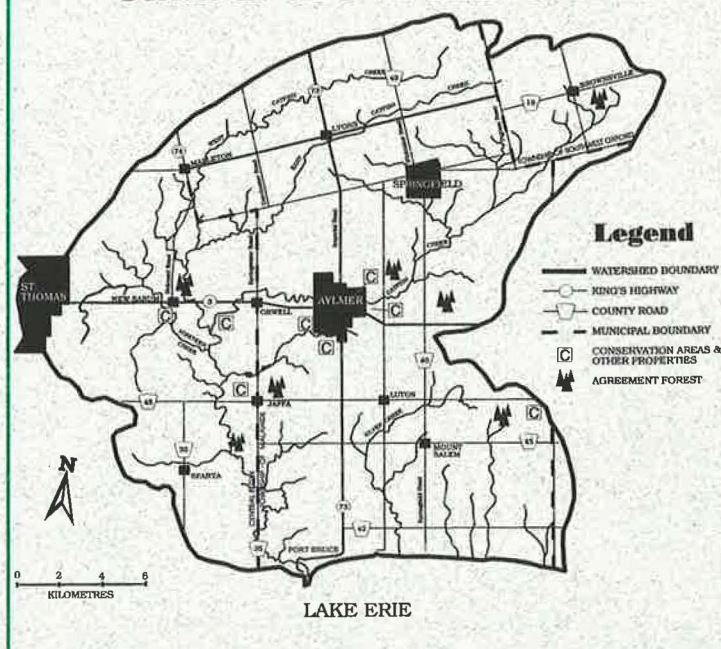
