Chairperson's Message

Across North America and throughout the world, the environmental/conservation movement has never been more visible. With natural events such as Hurricane Katrina in New Orleans or tsunamis devastating the Pacific nations, people are now starting to understand the relationship between environmental health and the health of society. Climate change is now a common conversation topic in every country. Subsequently, Conservation Authorities are at the head of many organizations that have stepped forward to address these issues, each tending to specific problems on a watershed basis.

Finishing 2007 as Chair of the Catfish Creek Conservation Authority (CCCA), I encountered a year filled with challenges and a flurry of activity demonstrated by the committed and happy energy of our small staff. It is through their pursuit of excellence in conservation and environmental protection that we enjoyed many achievements in 2007.

Our year began with one of the most successful Maple Syrup Festivals on record, welcoming thousands of visitors to the Springwater Conservation Area. Water and land management initiatives still continue to be a priority of utmost importance to the landowners throughout the watershed. Projects were launched ranging from reforestation, drinking water source protection, tallgrass prairie restoration at the Yarmouth Natural Heritage Area, low water response, watershed stewardship, fish and wildlife habitat restoration, riverine/shoreline bank stabilization/restoration works, and of course, environmental education.

As in past years, we continued to host special events, such as fishing derbies, the Fred Eaglesmith Charity Picnic, and the Christmas Spirit Walk which attract hundreds of new and repeat visitors every year, making the outdoor recreational and educational experience at Springwater one-of-a-kind.

We are now entering 2008 and the CCCA will remain focused on addressing our water quantity and quality issues throughout the watershed. We will continue with our strong public education and awareness campaign that is vital to the successful completion of any undertaking.

In closing, we would not have reached many of our program successes without the generous financial and logistical support of the hundreds of partners, stakeholders and volunteers who have helped and aided the CCCA with its many environmental endeavors.

WATER MANAGEMENT

- installed a new hydrometric streamgauge station on Silver Creek
- continual monitoring of streamflow and watershed conditions for flood forecasting and warning purposes
- received funding assistance through the Water and Erosion Control Infrastructure Program (WECI) to improve the channel hydraulics at the mouth of Catfish Creek in Port Bruce
- collected groundwater data through the Provincial Groundwater Monitoring Network
- participated in the Provincial Surface Water Quality Monitoring Program by taking samples once a month at seven stations in the watershed
- provided technical support to the Catfish Creek Low Water Response Team and the Catfish Creek Irrigation Advisory Committee
- received and reviewed the Draft Catfish Creek Watershed Characterization Report
- participated in an Emergency Planning Exercise with the Township of Malahide by staging a mock flood disaster in Port Bruce
- partnered with the Kettle Creek, Long Point Region, and Grand River Conservation Authorities to identify drinking water source protection issues within the Lake Erie Region Planning Area

ENVIRONMENTAL PLANNING

- coordinated the undertaking of two Biological Studies and Inventories in Calton Swamp as part of the Species at Risk recovery efforts for the endangered Small Whorled Pogonia
- provided technical support and policy development to local municipalities and proponents by reviewing and commenting on over 64 Planning Act Applications and development proposals
- received and provided comments on 26 Municipal Drain Reports and Drain Maintenance requests



Bradley Creek Rehabilitation Project

- reviewed over 22 proposals including issuance of 13 permits relative to fill placement, construction or alteration to watercourses in accordance with Section 28 of the Conservation Authorities Act
- provided responses to over 62 property inquiries (legal, real estate, and general information requests)
- obtained new orthophotography for the entire Catfish Creek watershed including the Lake Erie shoreline
- worked with the Elgin Stewardship Council and the Ministry of Natural Resources to update the Management Plan for the Calton Swamp Wildlife Management Area

WATERSHED STEWARDSHIP

- completed the final phase of the East Elgin Landscape Restoration Project funded through Ontario Power Generation's Carbon Sequestration and Biodiversity Management Program
- planted over 30,000 trees in the watershed
- provided certified staff to approve Managed Forest Tax Incentive Program Plans for private landowners
- implemented the management prescriptions at two municipal woodlots under Agreement with the CCCA
- provided technical expertise and financial incentives to several landowners for erosion control and fisheries rehabilitation projects on private lands
- designated as the local resource agency to provide technical input to landowners interested in undertaking environmental projects through the Greencover Canada Program. This new cost-share opportunity for Ontario farmers is being delivered by the Ontario Soil and Crop Improvement Association
- organized a creek cleanup through the Town of Aylmer utilizing volunteers from the local community
- participated as technical advisors on the Elgin Stewardship Council
- developed a list of potential fish habitat projects identified in the CCCA Fish Habitat Management Plan

CCCA OWNED LANDS

- worked with the Canadian Food Inspection Agency to monitor for the Emerald Ash Borer in forested areas owned and managed by the CCCA
- provided recreational opportunities and facilities on CA owned lands for over 70,000 visitors
- carried out woodlot management activities on a number of Authority properties in conjunction with the East Elgin Secondary School Environmental Leadership Program
- worked with a number of environmental partners to complete five fish and wildlife habitat restoration projects

- implemented major capital development improvements at the Springwater Conservation Area with better access and electrical upgrades for ten campsites
- completed construction of the Herb Kebbel Wetland Trail at the Yarmouth Natural Heritage Area
- received a grant from the Communities In Action Fund to develop a booklet that will encourage wider use of the trail systems on Authority owned lands
- benefitted from the use of a new Global Electric Motorcar donated by Daimler-Chrysler for operation in the Springwater Conservation Area
- re-surfaced .5 km of roads through the Springwater Conservation Area campground
- received funding from TD Friends of the Environment Foundation to upgrade the interpretive signage in the Springwater Forest
- completed a commercial timber harvest cut at the Hawkins Tract

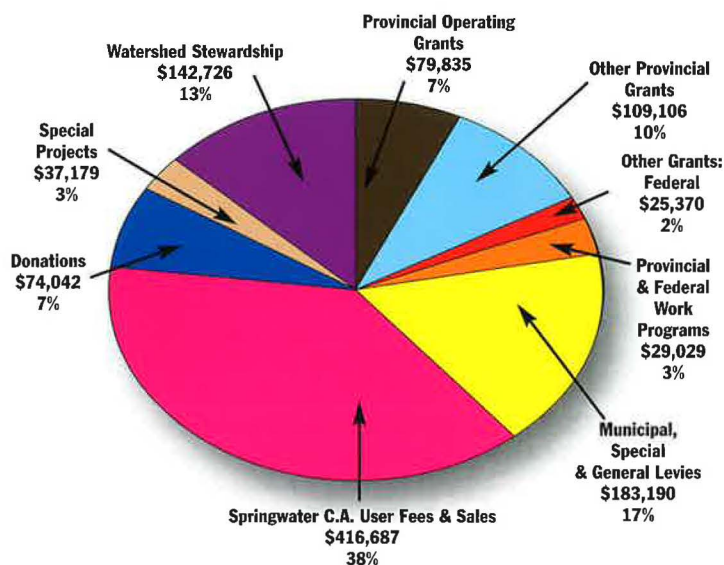

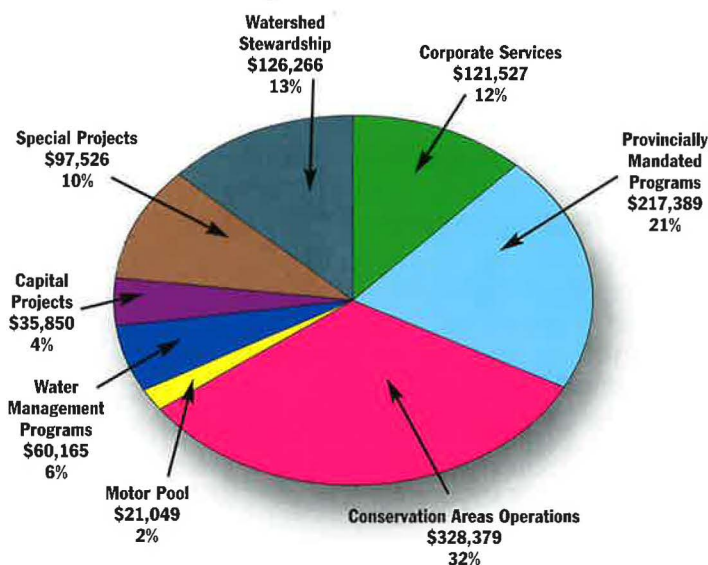
