My body was like a piece of lead, my last 3 days onsite, [hypoxia] and i was never sent for HBOT, Hyperbaric Oxygen Treatment! The treating Physician told me to RTW, Return to Work the next morning!

How much would Wsib have saved if this simple medical intervention had healed me, as it was attested, by a Neurologist, that I was over-exposed to Carbon monoxide and H2S, Hydrogen Sulphide? After 3.5 years of poverty, without telephone and hydro in my Ontario, for the last 5.5 months, I was finally awarded Entitlement for Toxic Fume Injury, on Full Disability Benefits for 14 years, until the age of 65!
