LINCOLNVILLE LAYOVER FUELLING PROJECT TOWN OF WHITCHURCH-STOUFFVILLE

Metrolinx, an agency of the Province of Ontario, is helping transform the way the region moves by championing and delivering mobility solutions for the Greater Toronto and Hamilton Area (GTHA). As we invest in the future and build stronger transit infrastructure to meet the growing needs of the region, a number of projects are underway including many involving our GO Transit division. GO service continues to be expanded and improved to provide more choices for travel across the GTHA, meet increasing customer demand and attract more transit users in the future.

THE PROJECT

GO Transit intends to add fuelling capabilities at the existing Lincolnville layover train storage yard, located at 13190 York Durham Line. The fuelling capabilities will improve operational efficiency, increase GO Train service reliability and support any future expansion.

The proposed work will include underground fuel storage, dispensing equipment, a new pump house building, a sanding system and environmental protection systems such as leak detection.

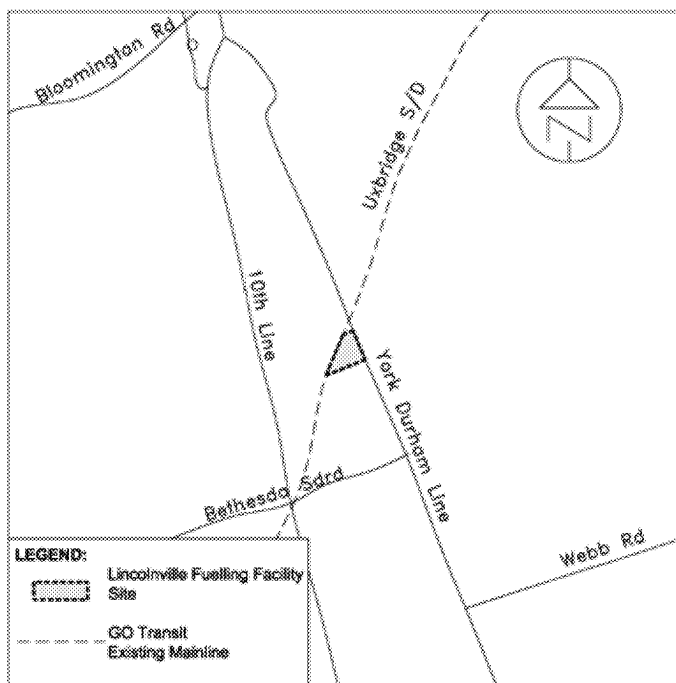
THE PROCESS

The fuelling will be operated in accordance with the *Technical Standards & Safety Act* and the *Liquid Fuels Handling Code*, which focus on the safe transportation, storage, handling and use of hydrocarbon fuel, reporting requirements, design guidelines, leak prevention and environmental protocols.

Information will be provided to the Town of Whitchurch-Stouffville, external agencies and members of the public throughout the project.
