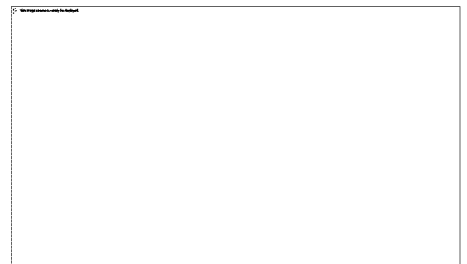
Otherwise; to ensure that agencies have time to complete the report, the submission deadline has been extended by one month to **June 25, 2012**.
