I'd like some assistance developing a standard response for questions about when the next round of open houses will be held for the Crosstown stations. I've only received email thus far, but I imagine there will be more.

Below is a suggested first volley.

Dear Personal Information

Thank you for your inquiry about the Crosstown project. The Crosstown project is funded by the Province of Ontario and delivered by Metrolinx, the provincial transportation authority. Metrolinx and Infrastructure Ontario will deliver the Crosstown using an Alternative Financing and Procurement model.

Contracts to carry out further detailed engineering design and architectural work will be developed and publicly tendered. Winning bidders will advance station design to further milestones including more detail about the architectural elements and construction methods. The next round of public consultations for the Crosstown will be scheduled upon award of the contracts for design. We expect this process to begin in the coming months and will keep the website up to date with info about progress on the project.
