PROGRAMME DESCRIPTION

The Legislation

The legislation under which the Board functions is The Compensation for Victims of Crime Act, which came into force on September 1, 1971 superseding The Law Enforcement Compensation Act, 1967.

The Board is required by the Act to find the commission of a crime of violence (in the principal class of applications coming before it). A basic qualification for the consideration of an award is that there must be adequate and reliable evidence in this regard. In addition, the Board is required to consider all relevant circumstances including the behavior of the victim at the time of the incident and the co-operation given by the victim to the law enforcement agencies.

Section 6 of the statute prescribes a one-year limitation period for filing an application for compensation, but the Board may extend the time as it considers warranted. During the year, 127 requests for extension of the limitation period were received, of which 100 were approved.

The Compensation for Victims of Crime Act presently provides that compensation for victims of crimes of violence may be paid up to the following maximums: In the case of lump sum payments, up to \$15,000, and in the case of periodic payments, up to \$500 per month, and where both lump sum and periodic payments are awarded, the lump sum shall not exceed half of the maximum of \$7,500.

It has been 12 years since these maximums were put into effect, and the Board feels that, having regard for the inflationary factors which have occurred since that time, very serious consideration be given to a substantial increase in its maximums, and respectfully recommends that this matter should be addressed by the Government as soon as possible.

Subrogation

The Board is subrogated to all the rights of any person to whom payment is made under this Act, to recover damages from the offender by civil proceedings in respect to injury or death. \$26,834.13 was recovered during the fiscal year, compared to \$30,982.76 in the previous year.

Hearings

The members of the Board, of whom thirteen are on a part-time basis, usually sit in panels of two.

During the fiscal year, hearings, in addition to those held in Toronto, took place in Thunder Bay, Sudbury, Sault Ste. Marie, Windsor, London and Ottawa. This is done to facilitate applicants, and to generate a better understanding of the work of the Board across the province. In addition, this practice results in reduced costs to the Board.

Documentary Evidence Hearings

A total of 96 cases were dealt with by documentary evidence during the fiscal year compared to 107 in the previous fiscal year.

Cases of this nature are relatively clear-cut. They are generally dealt with by the Chairman of the Board, sitting as a single member panel, after having received agreement from the applicant and the alleged offender to proceed in this manner.

Dealing with cases on documentary evidence reduces the inconvenience of both the applicant and/or solicitor with regard to travel time to location of hearing, as well as to the applicants' and witnesses' loss of work time. The Board also benefits substantially by an overall reduction in its administrative costs, vis-a-vis staff and Board members travel time, accommodation, rental costs, witness, and lawyers fees, etc.

Child Abuse

During this fiscal year the Board received 11 applications in respect of child abuse, heard seven cases and awarded \$41,568.00.

Administration & Productivity

The administrative staff of the Board is composed of the Registrar, Chief of Investigations, and three investigators, also a secretarial, stenographic and clerical staff of eight. This small staff has been most dedicated in its efforts to maintain a high standard of service to the Board and to the public. In this fiscal year, the Board has heard 928 applications, 950 awards were ordered during this fiscal year. The total value of awards increased from \$2,780,496.74 in 1981/82 to \$2,883,698.21 in 1982/83, while the average award rose from \$2,303.02 to \$2,451.54. Periodic payments of \$554,741.10 not included in average award.

The number of applications received increased from 1250 in 1981/82 to 1328 in the fiscal year.

Public Awareness

Large posters and explanatory pamphlets are supplied to hospital emergency wards and staff lounges, court houses and other public buildings, supermarkets, etc.

Police forces throughout the province have been provided with wallet-sized cards which are designed to be handed out to draw to the attention of the victims of crime of violence that they may be eligible for compensation and advising how to apply to the Board. The daily hearing agenda and a selection of typical Board orders are provided to the news media.

Cost Sharing

Awards made under The Compensation for Victims of Crime Act are cost shared between the Federal Government and the Government of Ontario. The contribution by the Federal Government amounts to 50% of the awards (net of any recoveries) to a maximum of ten cents per capita of the population of Ontario. For the fiscal year 81/82 this share amounted to \$862,500.00 or approximately 30% of the awards. The Federal Government does not share administrative costs.

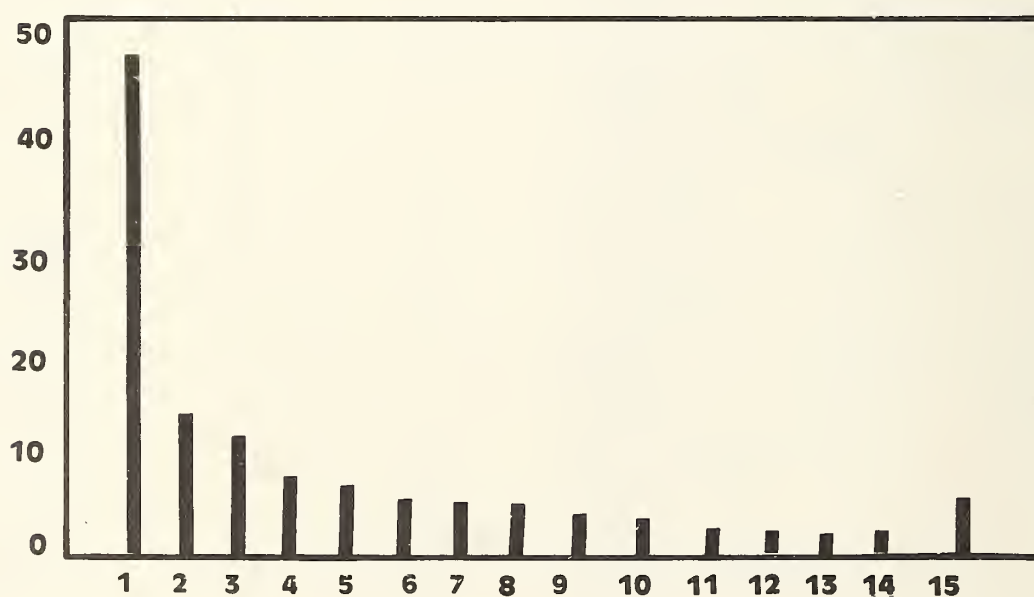

SUMMARY OF DECISIONS
APRIL 1, 1982 TO MARCH 31, 1983

The volume of cases dealt with by the Board is such that to prevent this report from becoming unduly long, every second Board Order has been summarized.

200-2656 A 39 year old service station owner was shot in the right side of his chest. The wound penetrated the diaphragm and damaged his liver. The offender, convicted of wounding and ABH, was sentenced to 60 days imprisonment and 1 year probation. Award: \$6,016.10 (incl. pain and suffering \$5,000.00)

200-3396 A 38 year old motor mechanic was stabbed when he tried to break up a fight between his brother-in-law and his wife. The applicant was wounded in the left neck and right lower back. The offender was convicted of ABH and given 3 years probation. Recommended for subrogation. Award \$2,055.10 (incl. pain and suffering \$2,000.00)

200-3866 A 40 year old jewellery repairman was assaulted when he intervened to protect his wife from the offender. The applicant sustained multiple injuries to his face, throat and chest, and injury to his right hand. He continues to suffer from confusion, memory loss and headaches. The offender was convicted of ABH and was given a suspended sentence with 1 year probation. The applicant was advised of Section 25* of the Act in case of continuing loss of income. Recommended for subrogation. Award: \$9,480.12 (incl. pain and suffering \$6,000.00 and loss of income \$2,236.50)

200-3908 A 21 year old female was the victim of assault and robbery. The applicant sustained swelling of the left jaw and eye, dental damage, and a fractured rib. The offender was convicted of ABH and sentenced to 3 months imprisonment and 2 years probation. The applicant was advised of Section 25* of the Act for dental expenses. Recommended for subrogation. Award: \$875.00 (incl. pain and suffering \$800.00)

200-4378 A 29 year old bartender was assaulted when he intervened in a fight involving the alleged offender. The applicant sustained a double fracture to the lower jaw and dental damage. The alleged offender was charged with ABH and a bench warrant is still outstanding. Award: \$1,952.50 (incl. pain and suffering \$1,700.00)

200-4487 A 21 year old male was assaulted with no provocation. The applicant sustained facial lacerations and a broken jaw. The offender was charged with ABH and fined \$200.00 or 20 days. Award: \$5,114.15 (incl. pain and suffering \$3,500.00 and loss of income \$683.00)

200-4770 A 15 year old student was shot while riding in his father's pick-up truck. The applicant sustained various wounds to the back and abdomen. The offenders were convicted of attempted murder and each was sentenced to 3 years imprisonment. Award: \$12,580.00 (incl. pain and suffering \$12,000.00)

200-4781 A 26 year old equipment operator was assaulted without provocation. The applicant sustained multiple contusions to his face, arms and shoulders, a scalp abrasion, an injury to his testicles, and developed psychiatric difficulties. Three of the four offenders received varying sentences on various counts including ABH and common assault.

Award: \$15,000.00 (incl. pain and suffering \$12,000.00 and loss of income \$3,000.00)

200-4863 A 23 year old unemployed female was injured in a dispute between a friend and a bar waiter. The applicant sustained a compound fracture of the right arm. The offender was charged with ABH and given a suspended sentence plus 1 year probation. The Board concluded that the applicant contributed, in part, to her own misfortune and invoking Section 17(1) of the Act reduced the award.

Award: \$2,558.75 (incl. pain and suffering \$2,300.00)

200-5024 A 29 year old waiter was assaulted without provocation. The applicant sustained a head injury, multiple bruises and lacerations and extensive dental damage. The offender was convicted of ABH and fined \$350.00 or 90 days. A warrant is outstanding for the arrest of a second alleged offender.

Award: \$3,973.00 (incl. pain and suffering \$2,500.00 and loss of income \$600.00)

200-5216 A 48 year old sales clerk was assaulted during a robbery at the store at which he worked. The applicant sustained injuries of the right patella. The offender was charged with theft and sentenced to 1 year probation.

Award: \$7,447.00 (incl. pain and suffering \$5,000.00 and loss of income \$2,447.00)

200-5354 A 32 year old cabinet maker was assaulted by a man with whom he had been drinking. The applicant sustained a fractured skull and fracture to the wall of the auditory canal. The charge of attempted murder was dismissed due to problems with the applicant's credibility. Due to the applicant's alcohol consumption, the Board cited Section 17(1) of the Act and reduced the award.

Award: \$9,025.00 (incl. pain and suffering \$3,000.00 and loss of income \$6,000.00)

200-5459 A 22 year old assistant gardener was assaulted while he was visiting the alleged offender's family. The applicant sustained a broken cheek-bone and dental damage. The alleged offender, who was charged with ABH, was given an absolute discharge.

Award: \$1,265.03 (incl. pain and suffering \$850.00)

200-5535 A 37 year old electrician was assaulted in a dispute regarding the applicant's estranged wife. The applicant sustained multiple bruises and abrasions. The offender was convicted of assault and was sentenced to 10 days or a fine of \$100.00.

Award: \$882.43 (incl. pain and suffering \$600.00)

200-5598 A 71 year old female was assaulted with no provocation. The applicant sustained a fractured left hip and shoulder. No charges were laid due to conflicting evidence.

Award: \$5,560.72 (incl. pain and suffering \$5,000.00)

200-5763 A 25 year old unemployed female was assaulted with no provocation. The applicant sustained a severe concussion, a left frontal skull fracture, multiple bruises to the body and facial lacerations. The alleged offenders were charged with ABH and acquitted due to complications involved in identification.

Award: \$3,121.75 (incl. pain and suffering \$2,750.00)

200-5844 A 46 year old housewife was assaulted by her neighbour when she became involved in a dispute between her son and the offender's son. The applicant sustained a broken arm. The offender was convicted of common assault and sentenced to 21 days imprisonment or a fine of \$200.00

Award: \$2,293.30 (incl. pain and suffering \$1,500.00)

200-5875 A 19 year old saw operator was shot with no provocation. The applicant sustained perforations of his pelvic colon and small bowel, as well as damage to the hip and femoral vein. The offender was convicted of discharge of a firearm and sentenced to 2 years less 1 day.

Award: \$5,898.56 (incl. pain and suffering \$4,000.00 and loss of income \$1,583.56)

200-5952 A 42 year old waiter was assaulted with no provocation. The applicant lost 5 teeth. The offender has not been identified.

Award: \$850.00 (incl. pain and suffering \$850.00)

200-6082 A 55 year old hotel owner was assaulted after an altercation. The applicant sustained various injuries including a concussion from which complications arose and he now receives a permanent disability pension. The two offenders were convicted of ABH and sentenced to 40 days or \$400.00 and 30 days or \$300.00 respectively.

Award: \$3,562.00 (incl. pain and suffering \$3,000.00)

200-6084 A 15 year old student was stabbed in the chest and hand by her grandfather with no provocation. The offender was convicted of attempted murder and sentenced to 1 day plus 3 years probation.

Award: \$600.00 (incl. pain and suffering \$600.00)

200-6174 A 48 year old taxi-driver was assaulted when he went to the aid of others being attacked by the offenders. The applicant sustained injuries to his head and face, broken ribs, and a broken nose. The offenders pleaded guilty and were sentenced to 60 days plus 2 years probation.

Award: \$9,435.00 (incl. pain and suffering \$7,500.00 and loss of income \$1,625.00)

200-6204 A 21 year old labourer was assaulted without provocation. The applicant sustained a mild concussion with severe post-concussion syndrome. Two offenders were convicted of ABH and each was fined \$200.00 or 10 days plus 1 year probation.

Award: \$8,235.60 (incl. pain and suffering \$3,000.00 and loss of income \$4,512.00)

200-6216 A 29 year old bricklayer was the victim of an unprovoked assault. The applicant sustained a stab wound to his lower left abdomen. The offender was convicted of wounding and sentenced to 2 years imprisonment.

Award: \$3,621.40 (incl. pain and suffering \$2,000.00 and loss of income \$1,168.40)

200-6371 A 14 year old student was assaulted without provocation. The victim sustained facial lacerations and dental damage. The alleged offender was charged with ABH; but due to administrative error, the charges were dismissed. The applicant was advised of Section 25* of the Act for dental work.

Award: \$1,045.00 (incl. pain and suffering \$500.00)

200-6478 A 47 year old part-time clerk was injured while escaping a fire in her apartment. The applicant sustained a bruise to her hip and two sprained ankles. The offender was convicted of arson and criminal negligence causing bodily harm and was sentenced to 15 months.

Award: \$730.00 (incl. pain and suffering \$600.00 and loss of income \$130.00)

200-6480 A 20 year old male was injured while escaping a fire in his parents' apartment. The applicant sustained minor burns to his lips and nose and a sprained right knee. The offender was convicted of arson and criminal negligence causing bodily harm and was sentenced to 15 months.

Award: \$491.92 (incl. pain and suffering \$400.00 and loss of income \$71.92)

200-6491 A 45 year old police constable was assaulted while investigating a complaint relative to stolen property. The applicant sustained a condition diagnosed as claustrophobic traumatic neurosis. The offenders were convicted of Assault Police and were fined \$500.00 or 50 days and \$250.00 or 30 days respectively.

Award: \$2,500.00 (incl. pain and suffering \$2,500.00)

200-6517 A 35 year old police officer was assaulted by an unknown offender while assisting at a fire that was believed to have been set by an arsonist. The applicant sustained a severe back injury.

200-6613 A 48 year old Immigration officer was assaulted while searching an apartment for illegal immigrants. He sustained soft tissue damage to the right side of the head and some bleeding in the right ear. The offender was convicted of ABH and attempted bribery; and was sentenced to 3 months on the first charge and 1 year on the second.

Award: \$200.00 (incl. pain and suffering \$200.00)

200-6632 A 55 year old waiter was assaulted when he went to the aid of the tavern manager. The applicant's glasses were broken and he sustained a laceration above his nose and fracture of the nasal bones. The offender was convicted of ABH and sentenced to 3 months.

Award: \$1,532.88 (incl. pain and suffering \$1,500.00 and loss of income \$20.00)

200-6637 A 40 year old unemployed female was assaulted with no provocation. While intoxicated the applicant sustained a fracture of the left zygoma. Recommended for subrogation.

200-6669 A 48 year old housewife was assaulted without provocation; sustaining multiple contusions and a cervical sprain. The offender was charged with ABH and was given a conditional discharge.

Award: \$3,675.00 (incl. pain and suffering \$3,000.00)

200-6686 A 31 year old male was hit by a thrown beer bottle while in a bar with friends. He sustained multiple lacerations and a hemorage in the right eye area. The offender was convicted of ABH and sentenced to 60 days plus 1 year probation
Award: \$1,348.25 (incl. pain and suffering \$1,000.00)

200-6760 A 22 year old unemployed male was assaulted during a robbery attempt by two unknown offenders. He sustained a fractured jaw.
Award: \$1,006.00 (incl. pain and suffering \$1,000.00)

200-6845 A 34 year old rooming-house owner was slashed with a razor when he opened the offender's door to collect back rent. The applicant sustained a laceration to the left side of his face. The offender was convicted of weapons dangerous and sentenced to 3 months imprisonment.
Award: \$3,554.50 (incl. pain and suffering \$3,000.00)

200-6874 A 37 year old assembler was assaulted when he intervened in a verbal dispute between the offender and an elderly person. The applicant sustained facial lacerations and dental damage. The offender pleaded guilty to common assault and was sentenced to 60 days or \$200.00
Award:\$587.31 (incl. pain and suffering \$250.00 and loss of income \$109.31)

200-6937 A 61 year old owner/operator of a janitorial service was assaulted with no provocation. He sustained head injuries, including lacerations and a concussion. One offender pleaded guilty to wounding and was sentenced to 6 months imprisonment and 2 years probation. The other pleaded guilty to mischief and was fined \$503.00 or 60 days.
Award: \$10,400.30 (incl. pain and suffering \$4,000.00 and loss of income \$6,000.00)

200-6951 A 21 year old male was assaulted without provocation. The applicant sustained partial amputation of his nose. The offender was convicted of wounding and sentenced to 3 years imprisonment.

200-7064 A 20 year old male was assaulted without provocation, sustaining severe head and brain damage. The offender was convicted of ABH and sentenced to 4 months imprisonment.

200-7099 A 22 year old truck driver was assaulted without provocation, sustaining abrasions and bruises to his face and suffered dental damage. The offenders were convicted of ABH and were sentenced to 1 month plus 2 years probation.
Award: \$884.00 (incl. pain and suffering \$600.00 and loss of income \$36.00)

200-7115 The applicant was the 51 year old wife of a murder victim. The offender was found not guilty by reason of insanity.

Award: \$646.64 (incl. loss of income \$321.64)

200-7136 A 25 year old cab driver was assaulted by a passenger, sustaining a bruise to the bridge of his nose and a blackened eye. The offender was convicted of ABH and sentenced to 6 months imprisonment.

Award: \$1,020.00 (incl. pain and suffering \$600.00 and loss of income \$100.00)

200-7174 A 75 year old female was assaulted without provocation, by a group of unknown offenders. The applicant sustained fractures to her left femur and left hip.

200-7244 A 51 year old messenger was assaulted by several unknown offenders, sustaining a gunshot wound to his left arm and witnessing the death of his partner.

Award: \$3,955.00 (incl. pain and suffering \$3,500.00)

200-7265 A 27 year old apprentice machinist was assaulted and left handcuffed in a car. The applicant sustained abrasions to his face and bruises to his chest. The offender pleaded guilty to unlawful confinement and was sentenced to 1 year imprisonment.

Award: \$3,364.45 (incl. pain and suffering \$1,500.00 and loss of income \$1,319.43)

200-7319 A 16 year old male was assaulted without provocation, sustaining dental damage. The offender was found delinquent and fined \$2,500.00. The applicant was advised of Section 25* of the Act for dental work.

Award: \$1,055.35 (incl. pain and suffering \$900.00)

200-7327 A 58 year old hair salon owner was assaulted during a robbery at his home. The applicant sustained cut flexor tendons and nerve damage. The robbers were never apprehended.

200-7498 A 17 year old male was assaulted without provocation, sustaining a concussion, swelling to his face and a laceration below the left eye. The offender pleaded guilty to ABH and was sentenced to 3 months.

Award: \$1,035.50 (incl. pain and suffering \$700.00)

200-7510 A 29 year old painter was assaulted without provocation, sustaining multiple bumps and bruises over his entire body and loss of vision in his right eye. As the applicant did not report the incident promptly, it was impossible for police to conduct an investigation. The Board therefore, cited Section 17(1) of the Act and reduced the award.

200-7517 A 35 year old draftsman was assaulted without provocation, sustaining contusions to his jaw and head and a fractured skull. The offender was convicted of ABH and fined \$200.00 or 20 days. Recommended for subrogation.

200-7551 A 39 year old restaurant owner was assaulted after he made sexual advances to the offender's wife. The applicant sustained a laceration to his head and bruising to the right forearm. The Board, citing Section 17(1) of the Act, reduced the award.

Award: \$2,492.25 (incl. pain and suffering \$500.00 and loss of income \$1,500.00)

200-7555 A 24 year old foreman was assaulted when he tried to eject the offender from his home. The applicant sustained multiple lacerations. The offender was convicted of ABH and sentenced to 6 months plus 1 year probation.

Award: \$3,065.54 (incl. pain and suffering \$1,800.00 and loss of income \$496.54)

200-7573 A 29 year old unemployed female was the victim of attempted murder. The applicant sustained multiple injuries including a concussion and a fractured nose. The offender was charged with attempted murder, but was found not guilty by reason of insanity.

200-7964 A 30 year old dishwasher was assaulted by an unknown offender, sustaining cuts and bruises to his face, injury of the nasal bone and dental damage. The offender was charged with ABH and fined \$150.00 or 5 days.

200-8114 A 31 year old unemployed female was assaulted, sustaining soft tissue injuries and abrasions to her neck. The offender was convicted of common assault and fined \$300.00 or 30 days.

200-8132 A 21 year old male was visiting the former girlfriend of the offender when he was assaulted. The applicant sustained a gunshot wound to his head and neck, lacerations to his hand and wrist. Award: \$3,067.00 (incl. pain and suffering \$2,500.00 and loss of income \$500.00)

200-8137 A 39 year old male was assaulted without provocation, sustaining lacerations to his lips and dental damage. The offender was not apprehended.
Award: \$628.00 (incl. pain and suffering \$500.00 plus \$429.00 on completion of dental work)

Award: \$2,682.47 (incl. pain and suffering \$2,000.00 and loss of income \$58.28)

200-8375 A 24 year old student was assaulted without provocation, sustaining lacerations to his face. The offender pleaded guilty to ABH and was sentenced to 2 months imprisonment.

Award: \$872.00 (incl. pain and suffering \$800.00)

200-8384 A 59 year old contractor was assaulted after knocking at the door of the alleged offender's apartment. The applicant sustained damage to the ligaments of his right hand. The offender was remanded to a mental institution.

Award: \$1,875.00 (incl. pain and suffering \$1,500.00 plus 25 payments of \$100.00 per month)

200-9056 A 29 year old electrician was assaulted by an unknown offender without provocation. The applicant sustained severe multiple injuries including a depressed skull fracture resulting in aphasia. The applicant was advised of Section 25* of the Act for further medical expenses.

Award: \$14,051.26 (incl. pain and suffering \$7,500.00 and loss of income \$5,566.00)

200-9058 A 20 year old dishwasher was assaulted without provocation, sustaining a fracture to his nose. The offender was convicted of ABH and fined \$200.00 or 10 days. The applicant was advised of Section 25* of the Act in case of expenses or loss of income.

200-6240 A 26 year old male was assaulted by four unknown offenders after drinking liquor with them at his residence. The Board cited Section 17(1) of the Act in denying this application.

200-6564 A 27 year old mechanic was stabbed in a fight. The applicant refused to co-operate with police. Citing Sections 17(1) and 17(2) of the Act the Board denied this application.

200-6756 A 29 year old autobody repairman was injured in a car explosion. The applicant is known for his criminal activities and refused to co-operate with police. The Board cited Section 17(1) and Section 17(2) of the Act to deny this application.

200-7183 A 37 year old telephone technician was injured in a dispute at work. The Board, concluding he had provoked the confrontation, cited Section 17(1) of the Act and denied the application.

200-7199 The applicant was the father of the victim who was murdered while negotiating for drugs. The Board cited Section 17(1) of the Act in denying this application.

200-7285 A 7 year old male was injured when he fell from a window. The Board, satisfied the injuries were the result of an accident, cited Section 5 of the Act in denying this claim.

200-7540 A 24 year old male was assaulted after striking the offender. The board cited Section 17 (1) in denying this application.

200-7587 A 44 year old male was injured by the alleged offender in a hockey game. The Board concluded that there was no crime of violence as required by Section 5 of the Act and denied the application.

200-7805 A 41 year old male claimed to have been assaulted without provocation. The Board concluded the applicant had been in a fight and was intoxicated. As well, he was unco-operative with police. The Board invoked Sections 17(1) and 17(2) of the Act in denying this application.

200-7919 A 32 year old chef was assaulted with provocation and while intoxicated. As well, the applicant failed to assist in identification of the offenders. The Board invoked Sections 17(1) and 17(2) of the Act in denying this application.

200-7969 The applicant was the widow of a murder victim who was on parole from a federal penitentiary. One offender was charged with murder and sentenced to life imprisonment and the other was killed by police while resisting arrest. The Board found that the victim was the author of his own misfortune and cited Section 17(1) of the Act in denying this application.

200-8209 A 20 year old unemployed male was stabbed by his common-law wife during a drinking bout. The Board, considering the intoxication of the applicant and the nature of provocation invoked Section 17(1) of the Act in denying this application.

200-8221 A 33 year old shipper-receiver was injured in a dispute regarding a previous assault on the applicant. Charges against the offender and the applicant were withdrawn. The Board cited Section 17(1) of the Act and denied the application.

200-8323 A 45 year old tennis instructor was bitten by the alleged offender's dog. The Board could not establish that the terms of Section 5 of the Act had been met and denied this application.

200-8352 A 41 year old unemployed male was allegedly mugged but did not report the incident until he was advised that the Board required a police report. The Board cited Section 17(2) in denying this application.

200-8550 A 20 year old labourer who was intoxicated, was stabbed when he provoked a fight with the offender. The Board invoked Section 17(1) of the Act in denying the application.

200-8557 A 41 year old unemployed female was assaulted while on drugs and was unco-operative with police. The Board cited Section 17(1) and 17(2) of the Act in denying this application.

200-8578 A 45 year old labourer was found lying in front of an apartment building. The applicant did not provide sufficient evidence that these injuries were the result of a crime of violence. The Board, in denying the application, cited Section 5 of the Act.

200-8684 The applicant was assaulted while intoxicated in retribution for testimony she had given at a trial. The applicant refused to help in identification of the offender and as a result no arrests were made. The Board cited Section 17(1) and Section 17(2) of the Act in denying this application.

200-8693 A 26 year old dock worker was assaulted and he refused to lay charges. The Board cited Section 17(2) of the Act and denied the application.

200-8758 A 27 year old inmate was assaulted and stabbed in retaliation for his crime of arson. The Board cited Section 17(1) of the Act in denying this application.

200-8770 The applicant was the father of a murder victim. The Board cited Section 5 and 7 of the Act in denying this application.

200-8776 A 17 year old student was injured when he agreed to a fight. The Board cited Section 17(1) of the Act and denied this application.

200-8783 A 35 year old unemployed male was assaulted while in breach of his probation. The Board cited Section 17(1) of the Act and denied the application.

200-8813 A 28 year old office worker fell down some stairs while indicating a suspect to the R.C.M.P. officers. The Board, not satisfied that the applicants falls under Section 5(b) of the Act, denied the application.

200-8997 A 22 year old assistant floor lady was injured in an accident, sustaining partial amputation of a finger. The Board cited Section 5 of the Act and denied the application.

200-9008 A 46 year old boat builder claimed he was assaulted when he objected to noise from the premises below his apartment. As the applicant was intoxicated and acted in an aggressive manner, the Board invoked Section 17(1) of the Act in denying the application.

200-9043 The applicant was the mother and grandmother of two victims who died as a result of a fire set by an arsonist. The applicant applied for compensation for nervous shock; but the Board, not satisfied there was sufficient evidence, denied the application.

200-9099 A 25 year old unemployed male was shot as he attempted to buy beer from a known bootlegger. The Board concluded the applicant knew he was committing an illegal act and cited Section 17(1) of the Act in denying the application.

200-9111 A 20 year old Excavator Operator was stabbed upon approaching the alleged offender in an aggressive manner. The Board, in consideration of the intoxication of the victim and his provocative behavior, invoked Section 17(1) and denied the application.

200-9124 An 11 year old boy claimed to be the victim of assault. The Board found that the alleged victim was the author of his own misfortune and invoking Section 17(1) of the Act, denied the application.

200-9133 A 47 year old unemployed male was assaulted after assaulting the niece of the alleged offender. The Board cited Section 17(1) in denying the application.

200-9138 A 20 year old male was injured in a dispute with the alleged offender. The applicant was intoxicated and refused co-operation with police. The Board cited Sections 17(1) and 17(2) in denying the application.

200-9175 The applicant was the wife of the victim who was murdered. There was no evidence of the applicant suffering nervous shock and no documentation to support financial loss due to the victim's death. Therefore, the claim was denied.

200-9413 A 30 year old salesman was allegedly assaulted by two unknown offenders. The applicant was intoxicated and refused to lay charges. The Board invoked Sections 17(1) and 17(2) of the Act in denying this application.

200-9417 A 28 year old male prison inmate was stabbed but refused to testify against the suspects. The Board cited Section 17(2) of the Act and denied the application.

200-9427 A 43 year old female was allegedly assaulted but failed to report the incident promptly and the alleged offender disappeared. The Board, in denying this application, cited Section 17(2) of the Act.

200-9473 A 28 year old truck driver was assaulted while intoxicated. The applicant was unco-operative with police and the Board cited Sections 17(1) and 17(2) of the Act in denying his application.

200-9493 A 24 year old labourer claimed he was assaulted while intoxicated and did not report the alleged assault promptly. The Board invoked Sections 17(1) and 17(2) of the Act in denying this application.

200-9517 A 23 year old unemployed male was injured after allegedly robbing the offender. The Board cited Section 17(1) of the Act in denying the application.

200-9619 A 34 year old male was injured in a fight that he started. The applicant refused to co-operate with police. The Board cited Sections 17(1) and 17(2) of the Act and denied the application.

922-010139 A 47 year old unemployed male was stabbed in the stomach while intoxicated. No charges were laid as no suspect was identified. The Board invoked Section 17(1) of the Act in denying the application.
